What is this product?

Type:

This product is a share of an investment company qualifying as an alternative investment fund (AIF) submitted to Luxembourg specialised investment fund law.

Objectives:

The sub-fund Aulien - Patrimonium (hereafter the sub-fund) seeks to offer shareholders an attractive positive return through a diversified multi strategy portfolio.

The sub-fund will predominantly invest in a diversified portfolio of equities, government and corporate bonds, commodities (through financial derivative instruments), currencies, structured products and alternative investment products.

The sub-fund will invest directly in the financial markets or through other collective investment vehicles.

This sub-fund was launched in 2011 and this product in 2012.

The reference currency of the sub-fund is expressed in EUR.

The currency of the product is expressed in GBP.

For this product, the foreign-exchange risk of the product currency is systematically hedged against the sub-fund's reference currency.

This product is a capitalisation product meaning that income and capital gains are reinvested.

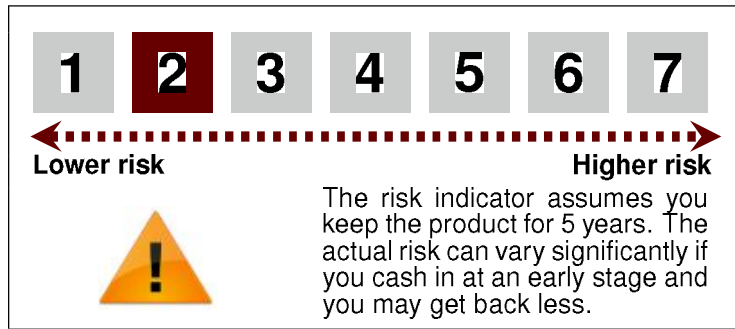
The intended target market is well-informed investors within the meaning of Luxembourg Law of 13 February 2007 (SIF Law).

Term of product:

This product has no maturity date. However, the manufacturer may decide to close the product under certain circumstances.

What are the risks and what could I get in return?

Risk indicator:



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

Costs over time

How long should I hold it and can I take money out early?

Recommended holding period: 5 years
